3. General information on data processing

3.1 Processing of personal data, purpose of processing

Your data will be processed solely for the following purposes:

- Handling of a short-term rental of a hall parking space.
- Invoicing the service

3.2 Legal basis for the processing of personal data

- Processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract (Art. 6 Par. 1 sentence 1 b) GDPR).

3.3 Recipient

- Internal recipients: Employee of specialized department (Aviation, Airport Operations, Operations General Aviation, Finance & Controlling)
- External recipients: None

3.4 Transfer to third countries

It is not intended to transmit the data to any third country outside the European Union.



3.5 Duration of storage

The data will be deleted twelve month after completion of the transaction. Invoice data is subject to the statutory retention period.

4 Data protection requests: Rights of the concerned parties to information, rectification, erasure, restriction of processing, objection, portability and withdrawal of consent.

Data subjects have rights to information on the personal data concerned, rectification, erasure, restriction of processing, objection to processing and portability of the data. In addition, data subjects have the right to withdraw a declaration of consent at any time.

Data protection enquiries on applications for short-term rental of hall spaces: To exercise rights related to requests for short-term rental of hall spaces, the party submitting the request can initiate contact, preferably by email at the following address: gat@munich-airport.de.

Rectification of data: In particular in case of changes or errors in the indicated data of the party submitting the request, the data subject can have the data rectified. Contact in such cases can be made as described by email at <u>gat@munich-airport.de</u>.

5 Right to submit complaints to the supervisory authority

Without prejudice to any other administrative or judicial remedy, you have the right to lodge a complaint with a supervisory authority, in particular in the Member State of your habitual residence, place of work or place of the alleged infringement if you consider that the processing of personal data relating to you violates the law. The supervisory authority in the state of Bavaria responsible for the non-public area of the airport is: The Bavarian State Office for Data Protection Supervision, Ansbach.

6 Obligation to provide personal data

Registering for short-term rental of hall space is a quasi-contractual legal relationship; the provision of data is necessary for the organizational processing of the request and the security review.



7 Automated decision making (including profiling) and the consequences

No automated decision making is carried out.
