

# **Data Privacy Policy**

#### 1. Introduction

This policy covers the processing of personal data in connection with business events organized by FMG, including registering for, preparing and holding them, follow-up activities and all other associated business contacts and related activities.

### 2. Responsible

## 3. Responsible controller under GDPR

#### 4. Reasons for processing personal data

Your data may only be processed for the following purposes:

- Invitations to business events
- Assigning participants to events
- Sending confirmations of participation
- Cross-checking with entries in the customer database
- Managing feedback on events
- Enabling business contacts among associated organizations
- Contacting the customer consultant at FMG
- Christmas gifts (business gratuities)

## 5. Legal basis for processing personal data

For data processing for any purposes other than those listed in part 4 above, appropriate consent will be obtained from you beforehand.

- Legitimate interests (Art. 6, Paragraph 1, Letter f of GDPR) in holding business events, checking participants at the entrance, and communicating information relevant to events.
- For implementing precontractual measures or performing contracts (Art. 6, Paragraph 1, Letter b of GDPR) or for providing information on organizational changes or additions.

# 6. Recipients

- Internal recipients: members of the implementing department
- External recipients: parties involved in organizing joint events



#### 7. Data transfer to non-EU countries

There is no intention to send data to any countries outside the European Union. Pictures taken of an event may, however, be sent to non-EU countries.

### 8. Duration of data storage

Data remain stored until the contractual relationship or legitimate interest ends.

9. Inquiries on data protection: rights of affected individuals to be informed about, rectify and erase stored data, to restrict and object to their processing and transferability, and to retract consent

Affected individuals have the right to be fully informed about stored personal data concerning them, to rectify and erase stored data, to restrict and object to their processing and transferability. Affected individuals also have the right to withdraw their previously given consent at any time.

**Inquiries regarding data protection in connection with invitations to events:** Individuals may exercise their rights in connection with registering for events by, preferably, sending an email to the following address: <a href="mailto:registration@munich-airport.de">registration@munich-airport.de</a>.

**Rectification of data:** Particularly if data provided by a registering individual should change or are incorrect, he or she may have them rectified by sending an email to registration@munich-airport.de as described.

#### 10. Right to complain to the supervisory authority

Regardless of whether or not you have already sought other administrative or judicial remedy, you have the right to complain to a supervisory authority, preferably in the EU country in which you reside or work or in which a presumed violation has taken place, if you believe that personal data concerning you have been illegally used or processed. In Bavaria, the responsible supervisory authority for private cases is the Bavarian Data Protection Authority (Bayerisches Landesamt für Datenschutzaufsicht) in Ansbach.

#### 11. Obligation to provide personal data

Registering for an event gives rise to a quasi-contractual relationship, and it is necessary to provide certain data in order for the corresponding service to be provided.

## 12. Automated decision-making (including profiling) and its effects

No automated decision-making is involved.
