+	You have booked your flight and registered the animal with the airline in advance (at least 24 hours before departure) and received a corresponding booking confirmation				
+	You have procured a suitable transport container that meets the following requirements:				
	 All IATA guidelines are met: <u>IATA - Traveler's Pet Corner</u> The floor and roof of the transport box must be solid and leak proof PETC: The non-rigid container must be leak and escape proof. The animal can sit, stand, turn around and lie down in a natural position Absorbent bedding that is suitable for the animal must be provided, for example a blanket (no newspaper or cardboard) Separate food and water containers must be provided, be

+	The animal is familiar to the transport box	
+	To calm the animal, there are e.g. a cuddle blanket, old clothes or the animal's toys in the transport box	
+	A leash, a suitable harness (recommended) or collar are provided for the journey	
+	You have informed yourself that on the day/time of arrival the animal can be cleared for entry at the destination (e.g. quarantine regulations, no public holiday, opening hours of the veterinary and customs authorities)	
2.	Departure Day	
+	You bring your animal in a suitable transport box to the check-in counter at least 2 hours, but not earlier than 3 hours before departure	
+	Please present the following documents for the animal at the check-in counter:	
	 the booking confirmation or the receipt ("Passenger Receipt") the official and veterinary documents for your animal (e.g. pet passport) 	
+	You pay the cost of transporting the animal at check-in or at the airline counter or transport cost was prepaid	
→	The IATA checklist is filled in together with the check-in staff	
→	All necessary notices and labels ("This way up", "Live Animal", etc.) are attached to the container	
→	Your animal, if it is a dog, was still being walked beforehand so that it could relieve	
+	The animal is not wearing a collar, leash, muzzle, harness or any object with which it could strangle itself	
+	In the hand luggage there is a leash and, if necessary, medication for the animal	
3.	Arrival	
→	AVIH: At your destination, please ask the staff at the luggage claim where you can pick up your animal. At most airports, this is done at the bulky and special luggage reclaim
